ABORIGINAL AFFILIATION

ULLUS Collective offers Professional Aboriginal Arts programs, projects and opportunities for professional creation, production, exhibition, performance and dissemination.

ARTISTIC DISCIPLINE

Identifying the artistic disciplines and their subcategories,

1. **Media Arts/ New Media:** Includes film, video, animation, radio broadcasting, audio recording, computer graphics, web, smart phone applications, interactive media...
2. **Performance Arts:** Includes live performance artistry such as dance, theatre, music, spoken word, etc...
3. **Music:** Includes Sound recording, audio engineering, live performance, etc...
4. **Visual Arts:** Includes paint, 2D/ 3D, sculpture, print making, photography, installation,
5. **Literary Arts:** Includes writers, authors, editors, publishers, etc...
6. **Syilx/ Traditional Arts:** Includes syilx and/ or traditional Indigenous art forms and practices from all disciplines.
7. **Artisans/ Textiles:** Includes artisans and crafters, seamstresses, designers, jewelry makers, etc...

PROFESSIONAL DEVELOPMENT

1. **Emergent Artist**
Identified as a professional artist in their first years (0-5) of public exhibition who is introducing themselves to the general public as a professional artist and/ or a professional artist who has less than three independent bodies of work publicly exhibited.
2. **Mid-Career Artist**
Identified as a professional artists with 5-10 years of public exhibition who is recognized by their peers as a professional artist in their chosen discipline and/ or
A professional artist with 3-5 independent bodies of work publicly exhibited
3. **Established Artist**
Identified and recognized as an expert in their chosen discipline by their peers and the general public.
4. **Youth Artist**
Identified as an artist under the age of 30
